#### **APPROVAL OF MINUTES**

Trustee Guerin made a motion to approve the November 20, 2024, Regular Meeting minutes as presented; seconded by Treasurer Priehs. **Motion Carried.** Treasurer Priehs made a motion to approve the December 4, 2024 Work Session Minutes; seconded by Trustee Guerin. **Motion carried.**

#### **ACTION ITEMS**

- **A.**) Law Enforcement Contract—The Lapeer County Sheriff contract will renew for \$50,239.04 for the 2025 year. Treasurer Priehs made a motion to accept the law enforcement contract; seconded by Trustee Guerin. **Motion carried.**
- **B.**) Parks and Recreation Plan—Treasurer Priehs made a motion to accept and adopt the Parks and Recreation Plan; seconded by Trustee Guerin. **Motion carried.** Clerk Jepsen thanked the Parks and Rec committee for their hard work.
- **C.**) **New Pavilion** Additional cost arose due to necessary grade issues and material cost. An additional \$1,500.00 is needed to complete the project. Trustee Guerin made a motion to approve the additional funds needed; seconded by Treasurer Priehs. **Motion carried.**
- **D.**) **Budget Amendments** Clerk Jepsen made a motion to increase the Contribution to Cemetery budget line by \$20,000.00; seconded by Trustee Guerin. **Motion carried.** Clerk Jepsen made a motion to increase the Roads Department budget line by \$45,000.00; seconded by Trustee Guerin. **Motion carried.** Clerk Jepsen made a motion to increase the Township Hall Department budget line by \$40,000.00; seconded by Treasurer Priehs. **Motion carried.** Clerk Jepsen made a motion to add Contribution to Water as a budget line for \$18,000.00; seconded by Treasurer Priehs. **Motion carried.**
- **E.)** Township Calendar—Trustee Guerin made a motion to approve the 2025 calendar as presented; seconded by Treasurer Priehs. **Motion carried.**
- F.) Closing an Account Treasurer Priehs made a motion to close the General Fund

Money Market account at Huntington Bank and put it into the General Fund account; seconded by Trustee Guerin. **Motion carried.** 

#### **OPERATIONAL MONITORING**

- **1. Treasurer's Report-** Treasurer Priehs reported that the ARPA Michigan Class account is closing; the account was used to pay for road work. Tax money is starting to come in. Clerk Jepsen made a motion to approve the Treasurer's report as presented; seconded by Trustee Guerin. **Motion carried.**
- **2. Planning Commission Report-** Planning Commission has not met. The next meeting is scheduled for February 2025.
- 3. Attorney's Report- None.
- **4. Supervisor Report-** Next year the Fire and AYSO contracts will up for renewal. The park plan will be submitted, and work will begin on grant funding.
